Dear Premier Ford,

The members of the Orillia Naturalists' Club are deeply concerned because Bill 66 will destroy conservation lands that many organizations like our own have worked hard to protect. These lands have significant ecological importance.

One of your election promises was to protect the Greenbelt. Now you have reversed this promise.

The four Acts that you want to change will greatly weaken not encourage business in our area – Simcoe County. One of the main businesses in our region is tourism. Tourism brings anglers and hunters to our area. The anglers need the Lake Simcoe Protection Act and the Clean Water Act. Without these Acts being strongly enforced the lakes and rivers become polluted and the fish populations decline greatly. Areas like the Greenbelt and the Oak Ridges Moraine contain large forested sections for deer and other wildlife which is why hunters are coming. These areas attract hikers, cyclists and naturalists. Many tourists come for the beautiful scenery here. One of the reasons people move here is because of its natural beauty. If the lakes are polluted and the forests are levelled the tourists will no longer come and spend their money.

The lands that are used for development should be in or near the cities and towns where the services that they require are available. The development lands should not be in the unserviced protected lands. It is destructive and expensive to have development in unserviced protected lands.

Premier Ford why do you want to destroy so much of your Province and ours that makes is very **Special**.

Hello Patricia,

We have received great feedback from residents in Simcoe North regarding Schedule 10 in Bill 66. I appreciated hearing from people directly - through email, letters, and in person meetings on their unique perspectives on Schedule 10 of the Restoring Ontario's Competitiveness Act, 2018. The feedback that I had received from the residents of Simcoe North was shared with the Minister from the Ministry of Municipal Affairs and Housing, Steve Clark, and the information we received was discussed at length. Upon reviewing what residents, stakeholders, MPPs, and municipalities were saying, it was decided that we would not be proceeding with Schedule 10 of Bill 66.

As you know, we recently introduced Bill 66 – the proposed Restoring Ontario's Competitiveness Act, 2018. Included in the legislation, were proposed changes to the Planning Act that would create a new economic development tool, the open-for-business planning by-law. The tool would be available to all local municipalities to ensure they can

act quickly to attract businesses seeking development sites by streamlining land use planning approvals.

The use of this tool would never have been approved at the expense of the Greenbelt or other provincial interests like water quality or public health and safety. Our Made-in-Ontario Environment Plan committed to strong enforcement action to protect our lakes, waterways and groundwater from pollution. We will build on the ministry's monitoring and

drinking water source protection activities.

That said, our government has listened to the concerns raised in regards to Schedule 10 of Bill 66 and when the legislature returns in February, we will not proceed with Schedule

10 of the Bill.

I value the feedback I received on this specific issue and I am proud to have been able to represent the feedback from residents of Simcoe North regarding Schedule 10 of Bill 66 at Queen's Park.

Ontario" Environment Plan which made the same commitment.

Provincial and municipal data show there is enough land already available in our towns and cities

for our housing needs up to 2041. There is also a surplus of land for new businesses and we

should be encouraging investment in these areas. By building within our existing towns and cities

throughout the Greater Golden Horseshoe we can increase the supply of affordable housing and

jobs in our existing serviced communities while holding firm on urban boundaries.

Protected farmland supplies local food and enhances food security at a time when prices are rising

and supplies from other countries are increasingly threatened. Farming is also economically

important and provides jobs to thousands. Sprawl onto farmland destroys farm businesses and

farm communities.

Water is critical to human survival. Opening areas that have been protected for the safety of our

drinking water to development threatens our long term health and increases flood risks. Natural areas provide habitat for wildlife, sequester carbon and mitigate climate change, provide

recreation and clean our air.

Once gone, farmland and natural areas are gone forever. Please keep your promise and change

Bill 66.
